Traditional sources of retirement income, such as Social Security, employer pensions, and personal savings often are not enough. More than 37 million in the workforce are over 50, a number that will rise as the workforce grows older and works longer.

AARP supports flexible employment practices, such as job sharing, flextime, and phased retirement. Employer training programs should be made available to help workers of all ages.

Many retirees must reenter the workforce to supplement their Social Security retirement benefits or to get health insurance. Only four states—including Utah—reduce unemployment insurance benefits for those who lose a job while on Social Security. AARP opposes this practice, as it penalizes those who qualify for unemployment insurance yet are denied the coverage they've earned.

Because of the economic conditions we are living in, I think retiree is not the correct term for many older people today. Out of economic necessity, greater numbers of older workers need to continue working past traditional retirement ages, and others are having to reenter the workforce. These workers should not be penalized when they lose a job, since they were still contributing/being taxed on their salaries for the unemployment insurance.

AARP is committed to achieving long term care reform so more people needing these services can remain in their homes and get services in the community. In Utah, the majority of long-term care spending is directed to nursing homes and institutions. Utah is ranked 47<sup>th</sup> in the country regarding the percentage of Medicaid dollars going to home and community based care of older people and adults with physical disabilities.

Several states have saved money and improved patient satisfaction with quality of care by shifting the allocation of resources, so a greater proportion provides services in the community and not in nursing homes. AARP supports the right of people to have more choice where they want to get services and how they manage their own care.

By supporting home or community-based care to be given equal status to nursing home based care, the overall cost of care will come down, and people can be cared for in a familiar place by their families.

AARP supports reforms to increase access to affordable, high-quality health care coverage for all Utahns, particularly those without public or private insurance or those at risk of losing coverage.

Making health care affordable is a shared responsibility among government, business, health care providers and individuals. Other reform options include opening existing public programs (e.g. Medicaid) to new categories of people who are uninsured.

We need to be providing healthcare in a more holistic fashion for people of all ages. This means focusing on prevention as well as coordinating care among providers. Coordination is especially important for older patients, who may be on multiple medicines for multiple health condition. This approach is better for them individually and us as a society.
