Traditional sources of retirement income, such as Social Security, employer pensions, and personal savings often are not enough. More than 37 million in the workforce are over 50, a number that will rise as the workforce grows older and works longer.

AARP supports flexible employment practices, such as job sharing, flextime, and phased retirement. Employer training programs should be made available to help workers of all ages.

Many retirees must reenter the workforce to supplement their Social Security retirement benefits or to get health insurance. Only four states—including Utah—reduce unemployment insurance benefits for those who lose a job while on Social Security. AARP opposes this practice, as it penalizes those who qualify for unemployment insurance yet are denied the coverage they've earned.

As the fastest-growing portion of Utah's population, seniors face unique situations as traditional sources of retirement income change. I am committed to enhancing financial security for seniors and working towards solutions that maximize independence for senior citizens and their families. Job training funding should always be available for everyone, especially older workers. I support older workers and will work to preserve, protect, and improve the social security system.

AARP is committed to achieving long term care reform so more people needing these services can remain in their homes and get services in the community. In Utah, the majority of long-term care spending is directed to nursing homes and institutions. Utah is ranked 47th in the country regarding the percentage of Medicaid dollars going to home and community based care of older people and adults with physical disabilities.

Several states have saved money and improved patient satisfaction with quality of care by shifting the allocation of resources, so a greater proportion provides services in the community and not in nursing homes. AARP supports the right of people to have more choice where they want to get services and how they manage their own care.

Our seniors deserve assistance in preserving their quality of life and achieving the highest possible level of health and well-being. I am committed to ensuring that older workers have access to affordable long-term health care, including home and community-based care options.

AARP supports reforms to increase access to affordable, high-quality health care coverage for all Utahns, particularly those without public or private insurance or those at risk of losing coverage.

Making health care affordable is a shared responsibility among government, business, health care providers and individuals. Other reform options include opening existing public programs (e.g. Medicaid) to new categories of people who are uninsured.

I believe that accessible healthcare is a right and every person should have access to basic and adequate healthcare. Escalating costs are due to a number of factors but comprehensive healthcare reform can help curtail some of these costs. Reducing the cost of healthcare starts with making provider and consumer incentives available for preventive care. Comprehensive healthcare reform will be the most successful when many avenues of change are implemented and with the cooperation and collaboration of business, government, healthcare providers, and individuals.
