LCE has a board designated quasi-endowment, which was established from funds received by LCE as a recipient of certain unclaimed monies from a settlement of a class action lawsuit against a Washington, DC cable company. The funds are invested in a broad-based portfolio covering multiple asset classes. LCE uses the income derived from these funds to support consumer protection activities for the elderly. LCE's Board of Directors approves the appropriation, if any, for spending based on an annual budget. The fair value of investments pertaining to this endowment at December 31, 2019 totaled \$5,201,710.

LCE has another board designated quasi-endowment to fund the expenses associated with employing a law student as a part-time law clerk to support LCE cases. The funds are invested in a broad-based portfolio covering multiple asset classes. The fair value of investments pertaining to this endowment at December 31, 2019 totaled \$433,274.

Donor-Restricted Endowment-

In January 2018, LCE received a gift to establish a donor-restricted endowment fund. In accordance with the terms of the donor agreement, investment income from the endowment fund will be used to fund expenses associated with employing law students or other young attorneys working on systemic reform or the ombudsman project. The value at December 31, 2019 is \$328,627.

If a member appointed shall resign, the AARP Chief Executive Officer shall appoint his/her successor to fill the remainder of the term of the resigned member.
