The funds are invested in a broad-based portfolio covering multiple asset classes. Spending from this endowment will commence when the endowment corpus has grown to a level sufficient to generate adequate income to support the goals of the program, a level to be determined by LCE's Board of Directors. The value at December 31, 2017 is \$394,930.
