*Whereas, a significant portion of Holly Springs' population is aging and aging population affects all – as individuals and as a civil society, and;*

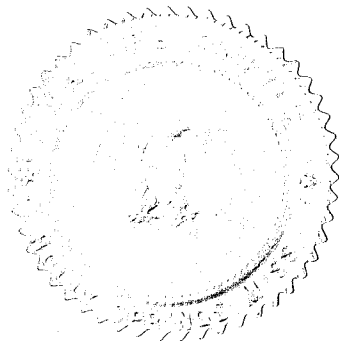
