Medicare Contributes \$8.5 Billion to Connecticut's Economy

Medicare helped pay the health care costs of 599,138 Medicare beneficiaries in Connecticut in 2017, allowing its seniors to get the care they need and protecting them from serious financial burdens.

In addition, Medicare is a critical part of the economic infrastructure of Connecticut, investing about \$8.5 billion in the state in 2017. Thousands of businesses, large and small, including hospitals, nursing homes, physicians' offices and medical device providers, rely on Medicare to exist and maintain their operations. Businesses in Connecticut receiving Medicare dollars use them to pay employee salaries, rent, and state and local taxes, as well as buy equipment and make capital improvements to their facilities.

In fact, Medicare spending in Connecticut is equivalent to about 19 percent of spending by state and local governments in Connecticut.

Here's how much Medicare* spent in Connecticut by health care service sector:

Hospitals	\$3.7 billion
Physicians	\$1.8 billion
Other health professionals	\$293 million
Skilled nursing facilities	\$752 million
Home health care agencies	\$455 million
Prescription drugs and medical supplies	\$1.3 billion
Durable medical equipment suppliers	\$82 million
Other health care providers	\$98 million

* Medicare only covers short-term skilled care in nursing homes, rehabilitation facilities and at home for an illness or injury; it does not cover long-term services at home or in a nursing home.
