14 Years of the Affordable Care Act: Impact on Adults Ages 50 to 64 in Oregon

The Affordable Care Act (ACA)—now 14 years old—has played a critical role in expanding access to affordable health coverage for millions of adults ages 50 to 64 in Oregon, including through ACA's health insurance marketplaces.

Since the start of the ACA, the number of adults ages 50 to 64 in Oregon with health insurance has increased from 676,633 in 2012 (out of 795,036) to 765,623 in 2022 (out of 819,767). Meanwhile, the share of adults ages 50 to 64 in Oregon without health insurance (the uninsured rate) has fallen significantly, dropping from 14.9 percent in 2012 to 6.6 percent by 2022. This decline marks a 56 percent drop in the uninsured rate for adults in this age group between 2012 and 2022.¹

In 2022, 54,144 people ages 50 to 64 in Oregon, or 6.6 percent of adults in this age group, remained uninsured. Policy actions have contributed to record-low uninsured rates. One such example is states keeping people enrolled in Medicaid during the COVID-19 pandemic in exchange for enhanced federal funding. Enactment of enhanced federal premium tax credits under the American Rescue Plan Act (ARPA) of 2021 and extended under the Inflation Reduction Act (IRA) of 2022 also helped make Marketplace coverage more affordable.

The percentage-point drop in the uninsured rate among American Indian/Alaska Native adults ages 50 to 64 between 2012 and 2022

Among adults ages 50 to 64 in Oregon, uninsured rates improved between 2012 and 2022 across many racial and ethnic groups. Specifically, the uninsured rate in this age group fell from 35.5 percent to 20.6 percent among Hispanic adults, 13.7 percent to 3.6 percent among Asian adults, 23.1 percent to 5.0 percent among American Indian/Alaska Native adults, and 13.8 percent to 5.0 percent among white adults.

Adults ages 50 to 64 who relied on nongroup (individual) health insurance in 2022

As of 2022, 8.0 percent of adults ages 50 to 64 in Oregon relied on the nongroup (individual) health insurance market for coverage. The number of adults ages 50 to 64 with nongroup coverage went from 57,795 in 2012 to 65,823 in 2022.

Adults ages 55 to 64 who enrolled in Marketplace coverage in 2024²

In 2024, 33 percent of Oregon enrollees in a Marketplace plan are between the ages of 55 and 64—totaling 48,137 people.

Adults ages 50 to 64 who are estimated to become newly eligible for Marketplace coverage after losing Medicaid³

As states lift the COVID-era restrictions on Medicaid disenrollment, many individuals are seeking new sources of affordable health insurance coverage. 8,000 adults ages 50 to 64 in Oregon are estimated to be newly eligible for Marketplace coverage after losing Medicaid. Of this group, 6,000 are estimated to be eligible for premium tax credits, including the enhanced premium tax credits under ARPA and IRA.

Marketplace enrollees who pay reduced or no premiums in 2024 due to federal tax credits²

Totaling 117,714 people, the majority (81 percent) of Marketplace enrollees of all ages in Oregon pay reduced or no health insurance premiums due to availability of federal premium tax credits.

The average monthly Marketplace premium after premium tax credits in 2024²

On average nationally, consumers (regardless of age) who receive premium tax credits in 2024 save more than \$700 per year on premiums due to the expanded tax credits under ARPA and IRA. On average in Oregon, Marketplace plan premiums are \$231 per month after tax credits, but 15 percent of Marketplace enrollees pay even lower premiums: \$10 or less per month.
