



Annotated Questionnaire

Telephone interviews conducted with 618 registered voters by landline (71%) and cell phone (29%) between 9/7/18 and 9/17/18. All data have been weighted by age, gender, race/ethnicity, and geographic distribution according to August 2018 Illinois State Voter Registration Database statistics. These survey results have a 3.9% margin of error.
