



Annotated Questionnaire

Telephone interviews conducted with 200 registered voters by landline (67%) and cell phone (33%) between 9/6/18 and 9/20/18. All data have been weighted by age, gender, and race/ethnicity according to August 2018 Texas State Voter Registration Database statistics. These survey results have a 6.7% margin of error.
